Spring 2022 Enrollment & Follow Up Visit Competitions

NARCRMS Leadership will host two (2) Spring 2022 competitions to encourage sites to enroll additional patients and to complete annual follow up visits. The competitions will begin on Monday, April 25, 2022 and will conclude on Friday, May 27, 2022. The site that enrolls the highest number of subjects and the site that completes the highest number of annual follow up visits during that period will be awarded an Amazon gift card. The winners will be announced in the next NARCRMS newsletter and on the website.

As a reminder, the NARCRMS Leadership would like to meet the goal of 1,000 patients enrolled prior to the CMSC 2022 Annual Meeting in June. In an effort to meet this goal, sites may now enroll up to 60 patients. Sites that have already met the milestone of 50 patients enrolled are asked to limit the enrollment of an additional 10 patients to those that are part of traditionally under-served populations in the MS community (i.e. ethnically and/or racially diverse). Sites that have not yet enrolled 50 patients may continue enrollments as usual. In addition, the newest sites activated will still be able to enroll up to 50 patients, even if we have already met the milestone of 1,000 patients enrolled.

The CMSC 2022 Annual Meeting will be held June 1—4, 2022 at the Gaylord National Resort and Convention Center in National Harbor, MD. The CMSC in conjunction with the NARCRMS Leadership is offering complimentary registration for one (1) Site PI and one (1) Coordinator from each NARCRMS site. - As a reminder the NARCRMS Leadership has temporarily lifted the enrollment cap of 50 enrollments per site. Sites that have already reached 50 enrollments can continue enrolling patients until otherwise notified.
- Sites should be in the process of resolving any data queries identified in OpenClinica. Training videos on how to address data queries can be accessed via the 'Site Resources' tab on the NARCRMS website (www.narcrms.org).
