Site Spotlight: Hackensack Meridian Health

Hackensack Meridian Health (Hackensack) in Hackensack, New Jersey has been open since 2016. The center serves over 1,200 patients of a diverse background. The PI of Hackensack, Dr. Florian Thomas, shared information about himself and the center.

Upon completion of a fellowship in neuroimmunology at Columbia University & a PhD in molecular neurobiology at McGill University, Dr. Thomas joined the faculty of St. Louis University in 1995. There he was asked to build MS Centers both at the University Hospital and the VA Medical Center, which quickly were certified by the National MS Society. In 2016 he was offered the opportunity to found a Neurology Department at Hackensack University Medical Center and the newly established Hackensack Meridian School of Medicine. Hackensack now has 3 MSologists, 4 psychologists, 2 neuro-urologists, several advanced practice providers, a dietitian, and 1 neuro-ophthalmologist.

Dr. Thomas works hard to address concerns during in-person patient visits and he is responsive to their questions between appointments and acknowledges when to reach out to other field experts for patient care. It takes a concerted effort to enroll patients and complete data collection. Patients have complex needs including mobility impairment and other functional needs. Dr. Thomas and his team enjoy seeing patients at patient advocacy events such as support meetings and MS walks.

Dr. Thomas highlighted Zakir Gulam, the manager of their research division, for performing the key responsibility of collecting medical data for NARCRMS. Hackensack also has other divisions engaged in interesting research. The Clinical Research Division conducts multiple clinical trials on stroke, spinal cord injury, neuromuscular conditions, and dementia. Looking for first treatments ever for spinal cord injury & hereditary neuropathies may offer hope to people for whom no medical treatment exists yet.

Refined Dataset Updates

NARCRMS is pleased to announce the release of refined datasets. As a reminder, the refined datasets are supplemental to the real-time data available via the NARCRMS Reporting Tool, Insight. Stakeholders will still be able to access the real-time data through Insight. The refined data sets will be updated approximately three (3) to four (4) times per year, will be made available to all stakeholders upon request, and will not require additional data cleaning by the stakeholders. The datasets will be broken out by visit type and CRF.

A code book or cover sheet will be made available with each refined dataset to provide a high level summary of the data and responses included in each dataset. The code book will also provide information about what is and is not included in the refined dataset (e.g., number of responses for each question, when skip logic was utilized and response(s) are not expected).

The NARCRMS Data Management Team completed the refined datasets for enrollment CRFs on health-related productivity, health-related utilization, clinical exam, cognitive logs and MS history. The remaining enrollment datasets and follow up datasets will be released as they become available over the next few weeks. **The NARCRMS Leadership team encourages you to utilize the datasets for analysis**. NARCRMS Stakeholders should contact NARCRMSOpsCenter@dlhcorp.com to request the refined datasets. The process to request refined datasets will also be added to the NARCRMS website (www.narcrms.org) in the coming weeks.

Site Competition—PROs

The NARCRMS Leadership would like to encourage sites to have patients enrolled in NARCRMS complete PROs at enrollment, follow up, exacerbation and DMT change visits. The NARCRMS Leadership will host a Fall/Winter competition in order to complete as many PROs as possible. The competition will begin on Monday, December 11, 2023 and will conclude on Friday, January 19, 2024. The site that has the highest number of PROs completed during this period will be awarded an Amazon gift card. The winner will also be announced in the next NARCRMS newsletter and on the website.

Announcements

- Sites that have not yet enrolled fifty (50) patients can continue enrolling and sites that have enrolled fifty (50) patients can continue enrolling up to sixty (60) patients total as long as those patients are ethnically or racially diverse.
- Sites should remember to invoice NARCRMS for every 5 completed enrollments and annual follow up visits. Please send invoices, particularly for older patient enrollment and follow up visits, as soon as possible to: <u>NARCRMSOpsCenter@DLHCorp.com</u>
- Sites should be actively resolving any data queries identified in OpenClinica. Training videos on how to address queries can be accessed via the 'Site Resources' tab on the NARCRMS website (www.narcrms.org).
